In the hybrid model, students will be divided into two cohorts. These students will receive two days of in-person instruction and three days of remote learning each week. The days of the week that they receive in-person instruction will depend on the cohort they are assigned. Students participating in the fully remote model will be the third cohort. These students will interact with their teachers Schoology and Zoom as well as other digital tools that may be part of the curriculum for each subject. No matter the cohort, all students will use the same curricular materials and participate in lessons focusing on the same standards and learning targets.

Cohort 1 will be half of the student population who chose in-person instruction with the exception of students who are participating in Academic Challenge. All Academic Challenge students will be part of Cohort 2. Students in Cohort 1 will report to school and receive in-person instruction on Mondays and Tuesdays.

Cohort 2 will be the other half of the student population who chose in-person instruction and all Academic Challenge students. Students in Cohort 2 will report to school and receive in-person instruction on Thursdays and Fridays. Additionally, Academic Challenge students will participate in their Academic Challenge classes remotely on Tuesdays.

Cohort 3 will be all students who choose remote learning. They will receive instruction on Wednesdays for their full schedule. They will also have the opportunity to contact their teachers at a set time period each day (office hours) during their teachers' planning periods.

Both the hybrid model and the remote model will focus on the following areas to ensure high levels of accountability and rigor for all students:

Attendance: In-person attendance will be recorded each day by the classroom teacher. When working remotely, students will be required to connect via a daily check-in or attendance statement in Schoology that will provide evidence of attendance for each remote session.

Grading: Teachers will follow Board Policy 213: Grading of Student Progress for both models. Families can expect assignments and due dates to be posted in Schoology.

Technology: All students from K-12 will have an iPad. The "Clever" app will remain "home base" for accessing instructional apps and learning platforms. Students are familiar with "Clever" and its accessibility, but please contact your child's teacher if you have questions.

Daily Learning: Cape's focus has always been on rigorous, standards-based instruction and assessment and high-quality instructional materials. Daily schedules will include opportunities for live, synchronous, learning as well as asynchronous, self-paced learning.

Office hours: As stated above, office hours will be scheduled on a daily basis and will provide consistent, real time learning support from your child's teachers.
